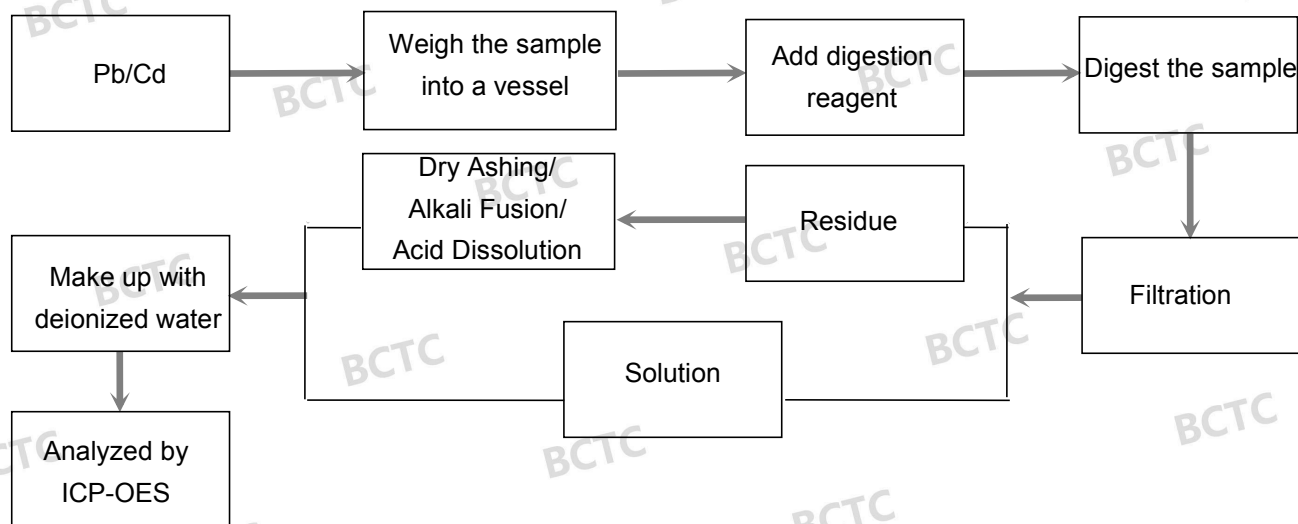
- The screening results are only used for reference.

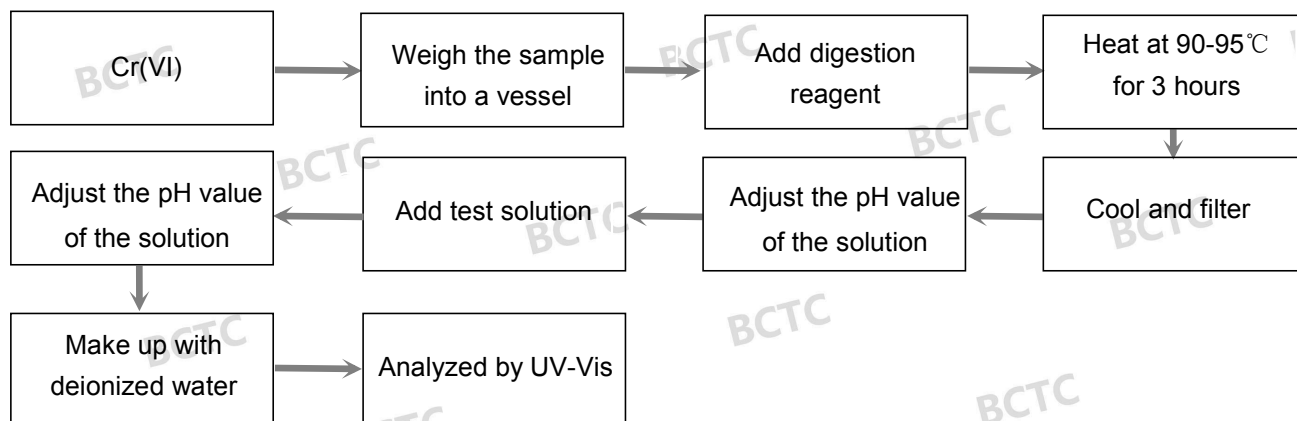

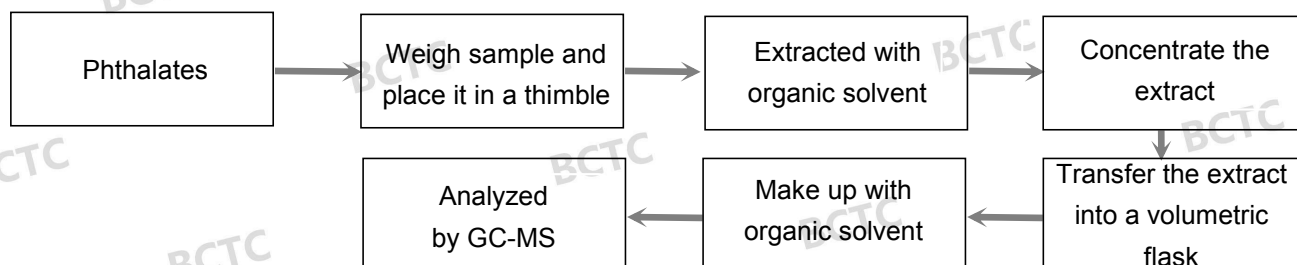

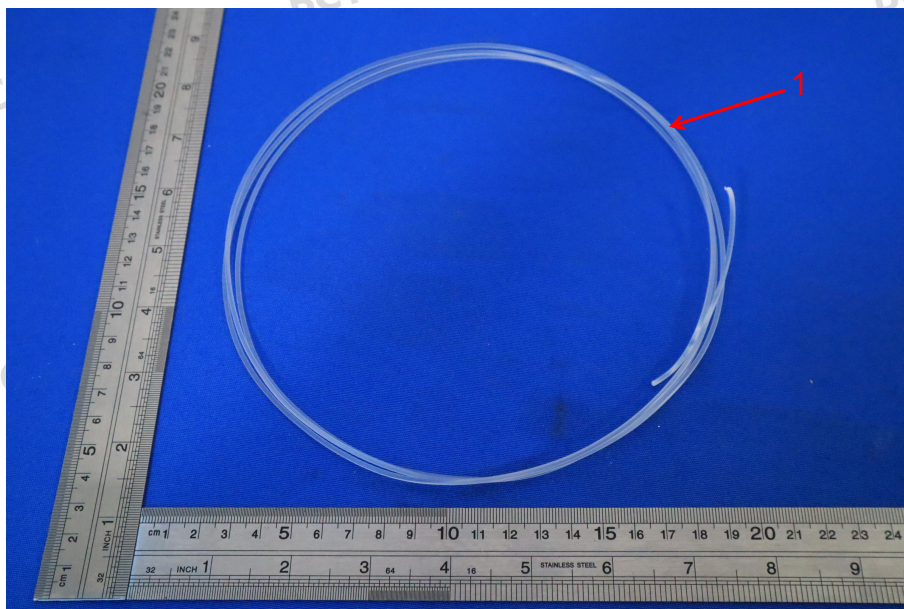

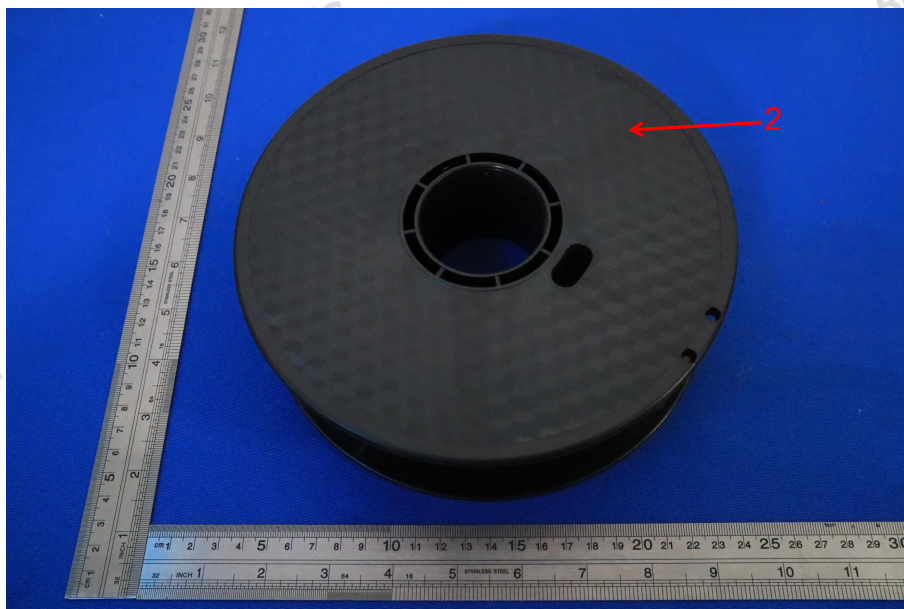

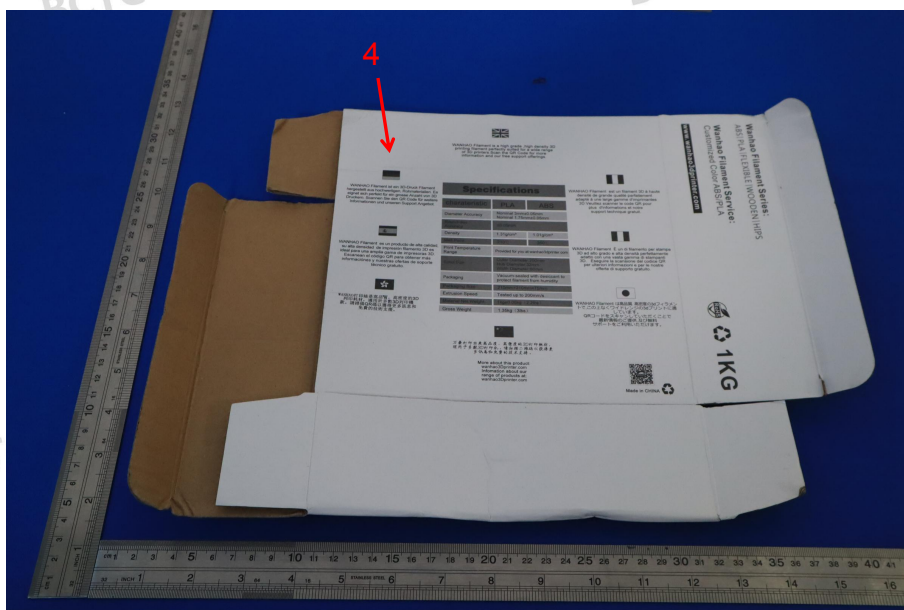
